- Any entries suspected of using fake likes or paid promotions will be disqualified from the competition.
- Entries must be submitted via the official application form between 1 November – 31 December 2024, 23:59 (SAST).
- Entries submitted after the closing date, 31 December, 23:59 (SAST), will not be accepted
- By submitting an entry, you are agreeing to be bound by these Terms and Conditions.
- EKN MAPUTO will not accept responsibility for entries that are lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any, equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind.
- EKN MAPUTO reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of the competition.
